OHIO ATHLETIC COMMISSION

Minutes of the June 13, 2017 meeting of the Ohio Athletic Commission (“OAC”) held at 10:00 A.M. at the Bureau of Workers’ Compensation, Garfield Heights, Ohio.

- I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Director Bernie Profato. Roll call was taken by Mr. Profato. Present for roll call were: Commissioner Schuerger, Commissioner Dr. Armile, Commissioner Stainbrook, Commissioner Mancini and Commissioner Patton.
- II. The minutes of the May 9, 2017 meeting were first on the agenda. Commissioner Stainbrook moved to approve the minutes. Commissioner Dr. Armile seconded the motion and it was unanimously approved.
